Subject :- Certificate of recognition of the school for the purpose of Section 18 of the right of children to Free and Compulsory Education Act 2009 under sub-rule (4) of rule 11 of the right of children to Free and Compulsory Education Rules, 2011.

Sir / Mam,

Based on the self declaration submitted with your request and the inspection report of the school given by the Inspection Committee, Dream Achievers Public School (kohala) is recognized from class pre-primary to class 8th for the three years.

Above recognition is based on the following conditions:

1. The approval of the accredited is not extendable and under no circumstances it should be taken to mean that is compulsory for affiliation of classes above 8th.
2. The school shall follow the provisions of the Right of Children to Free and Compulsory Education Act 2009 and the Right of Children to Free and Compulsory Education, 2011.
3. The school shall enroll 25% of the total number of children belonging to weaker sections and underprivileged groups in the first class and Free and Compulsory Education will investigate it until completed.
4. For children, referred to in paragraph 3, the expenses shall be reimbursed in accordance with the province provisions of sub-section (2), of the Section (12) of the Act. The school will have to maintain a separate bank account to receive this.
5. School shall not charge any competition fee and shall not adopt any method of selection by his parents or surplus.



6. The school shall not refuse admission to any child for lack of proof of birth and shall follow the provisions of Section 15. The school will ensure that :-

I. No enrolled child shall be withdrawn from school until his Elementary Education is completed.

II. No child will be given physical or mental distress.

III. As per rule 23, every child who has received Primary Education will be issued certificate.

IV. To the provisions of the Act, the handicapped students will be participated.

V. It is necessary for the teachers to fulfill the minimum educational qualification under the Act 23.

VI. Under the Act 24(1), teachers will complete their responsibilities.

VII. Teachers will not indulge themselves in private tuitions.

VIII. School must teach Punjabi from class 1 and Hindi from class 3.

IX. School will make it mandatory to fill u dice every year.

7. School will follow the syllabus prescribed by the appropriate authority based on the subjects of study.

8. The School shall comply with the terms and conditions prescribed in section 19.

9. On the same name of the school, any unrecognized class will not be run inside or outside the school building.

10. The school building or other structure or grounds shall be used only for academic or skill development.



11. School, by a society registered under the school societies Registration Act 1860(21 of 1860) as applicable from time to time being administrated by a trust created under any law.

12. The school shall renew the required documents like building certificate, fire safety certificate after expiry and deposit its copy in the office of the District Education Officer (AS), Amritsar. If the school is found to be neglecting his task, then the recognition of the school will be cancelled without giving any notice.

13. School shall not be run for the benefit of any private group or individual or any other group.

14. Accounts should be audited by a certified chartered accountant and statement of accounts prepared as per rules. A copy of each account will be sent to the District Education Officer every year.

15. School will make sure to follow the instructions regarding School transport issued by the School Government/ department from time to time. School will ensure to follow the safe School vehicle policy issued by School Government/ department.

16. Your school's recognized code number is RTE Amritsar- 02181039. It should be noted and recorded while corresponding with the office.

17. The school shall furnish the information called by the Director or the District Education Officer from time to time and school will follow the conditions of recognition instructed by the Punjab Government / local authorities.

18. Registration or renewal of institutions, if any, should be ensured.

19. School will strictly comply with the terms and conditions contained in The Punjab Regulation of Fee of Unaided Educational Institutions Act, 2016 (Punjab Act No. 47 of 2016).
